Dear MAHs, Dear representatives,

Following the release of the Product Management Service (PMS) by the EMA, we have started to map the products in our national databases to PMS data using the authorisation number, procedure number, product full name, package description and any other product data.

Some information is not correct for **MRP/DCP and national procedure**. Please update XEVMPD and if applicable, PMS with the **correct MA number** as soon as possible.

- MA number in Luxembourg: 10 digits e.g. 2025010012 (YYYYMMXXXX)
  - Examples of **incorrect** MA number:
    - 0376828
    - 0178/09060393
    - 0687/05/09/8240
    - 2025020036,0974518
    - LU2025020034
    - 2007/020028
- Presentation number/national number (NN): 7 digits e.g. 0962811
- For XEVMPD, please add the national number in the comment section and not with the MA number.
- For PMS/ XEVMPD: Pharmaceutical dose forms, route of administration, units of presentation, package description as in SmPC and as stated in the guidance (WHO, EDQM, MedDRA list) not as mentioned in the LU MA.

If needed, MA and NN numbers are listed on the MA document and tax documents. Please check that all valid medicines are in XEVMPD/PMS.
